- Monitor bills pertaining to PERS during legislative sessions, and contact the appropriate officials to support retiree interests.
- Keep members informed of state and national legislation which could impact the lives of PERS retirees.
- Take a position regarding measures aimed at reducing PERS benefits.
- Provide opportunities to meet and connect with other PERS retirees in your area.

Our meetings are the first Tuesday of Oct. Dec., Feb., April, June, and are held at the Campbell Senior Center at Second and High streets in Eugene.
